IMPORTANT INFORMATION :

1. The examination (Theory and Practical) will be held as per the programme even if any of the date (s) is subsequently declared as holiday (s).

 Candidates are advised to enter the examination centre 30 minutes before the commencement of the examination in a sitting, and enter the examination room/hall before 15 minutes of examination to occupy their seats allotted to them.

3. Before sitting, a candidate has to ensure that she/he has occupied the seat allotted to her/him.

 Distribution of answer books to the candidates will be made 15 (Fifteen) minutes before the commencement of the examination.

5. Question Papers will be distributed 05 (Five) minutes before the commencement of the examination. However, the candidates will be allowed to write the answers from 10 AM onwards.

6. The examinations will be conducted under CCTV Surveillance. The centre superintendents are requested to ensure that CCTV is made functional in all examination halls well in advance of the commencement of examination and to see that CCTVs are functioning throughout all sittings uninterruptedly.

7. The examinations of Biology of Science stream (Section-A: Botany & Section-B: Zoology) for both regular and exregular candidates will be held in a single sitting with a gap of 20 (Twenty) minutes in between. First the candidates shall be supplied with Biology Section-A (Botany) questions at 10 A.M. After that, Biology Section-B (Zoology) question paper shall be given at 11.50AM after collection of answer booklets used by candidates for answering Biology Section-A(Botany) paper.

 All Regular candidates (registered in the year 2022) and Ex-regular candidates (Registered in 2021) shall have to appear AHS Examination-2024 with the syllabus and pattern as detailed in the CHSE notification No.5682/Dt.10.10.2023

9. The Ex-Regular (registered up to 2020 shall have to appear AHS Examination-2024 with reduced syllabus prescribed during COVID19 pandemic situation (Vide CHSE notification No.3886 Dt. 19.07.2022) and the and the pattern of question will be like that of Annual H.S Examination 2022 and that of Ex-Regular candidates (Registered up to 2020) who appeared in AHS Examination-2023.

10. For the project evaluation and viva-voce in Commerce stream, groups are to be formed taking minimum 24 students in a group. Evaluation and viva-voice of a group is to be completed in three hours.

 The duration of practical examination for integrated Vocational Practical subjects (IVS) and Vocational Trade subjects will be three hours.
